Football Uniforms:

N. Sannes made a presentation of options for new football uniforms.

- Under Armour DeMan's Team Sports in Brookville, PA.
- Jerseys total of 265 units
- \$53.90 for youth. \$59.40 for adult sizes
- Free Personalization for 12U team
- Pants \$24 youth, \$29 adult. Pads integrated. No logo.
- 30 Coaches Shirts free. (\$1,200 credit)
- Flag Football Shirts \$5.25 SS, \$7.50 LS

- Poms about \$3 less than previous vendors
- Team Store options available for fund raising
- Total costs for all: approximately \$25K

Budget and Finance:

Armando Ferri has developed a draft budget based upon spend requests from all Board Members. For the last several years, the Board has set aside money for long-term projects, including capital expenditures required by Cranberry Township, uniforms, helmets, etc.
