#### **President's Report – Matt Curran**

Coaches application for Cheer and Football - interview process

We will be reviewing the registration numbers at the May and June meetings. Several of the communities close their registration in May. This will be done as part of a discussion on how to "align" the conferences, as well as to determine whether or not to raise registration fees (we pay for each team in the league). As I have mentioned, we need to have a big month for registration in April.

Several of the communities mentioned that they will not be having 12 year old teams this year. It seems the 12 yr old division will be even smaller than it was last year.

Per the weight rule changes that Steve outlined, we were against raising the weight limit for the 6/7 yr old kids and got the other communities to agree. We were in agreement of raising the max weights at all of the other levels but were the lone dissenter in raising the skill weights, as Steve mentioned.

We had a lively discussion about the officiating problem, largely led by us - We will be looking for input from you before the May meeting so we can write up and provide the "expectations" for the referees. Jeff Fabus will be gathering these from all of the communities and will be taking the lead in bringing them up to the officials. Football Report - Steve Kio

Last night the G19 made huge strides in player safety by drafting and voting in to place a new rule into the bylaws which PASSED 8-0

Any player initiating contact with the crown of the head, making contact with the facemask facing the ground, or using the helmet as a weapon in any way will be given a 15 yard penalty. Repeated offenses could be cause to be disqualified from the contest.

This is a great first step by the G19 to corral the officials into recognising the shortcomings of the official's lack of knowledge and/or desire to make a call pertaining to "head hits". "We go by WPIAL rules" will no longer be acceptable answer for ignoring dangerous head hits.

I also asked to have put into the G19 bylaws that all G19 rules and bylaws supercede WPIAL rules on a G19 field.

6/7 No Change 90 max/81 skill
8/9 new rules 115 max/ 102 skill
10/11 new rules 135 max/ 120 skill
12 160 max/ no skill weight
13 125 max/ 115 skill weight
SV voted no to raising any skill weights

The 6 minimum play rule is now extended throughout the playoffs. Passed 8-0

May meeting we will be drafting our Referee Expectation/ Rating system. Each referee will be given a card with the rules specified to each age group with them. The suggested new policy is before each game the referees will hand the head

coaches a card with his name on it. The head coach will rate the officials on performance and demeanor. After a given period the referees will be evaluated by the G19, and those refs who are of lower rating will not be used in he playoffs. Promptness can also be noted in the rating.

All referees will not be paid until AFTER the game they are officiating.
